

Admission Arrangements for Year 7 2023-2024 entry Wallington County Grammar School 20/10/2021

Introductory Statement

The Admissions Authority for Wallington County Grammar School is Folio Education Trust. The admissions function has been delegated by Folio Education Trust to the Local Advisory Board of Wallington County Grammar School.

Wallington County Grammar School is an 11 - 18 selective school for boys and accepts girls into its Sixth Form. Our motto is Per Ardua Ad Summa, '*Through Difficulties to the Heights*' and coming to school here as a student or professional means that we reach those heights daily by being part of such a successful educational organisation. What makes us great is that we meet life's difficulties together, as a community and a family, using our core values of compassion, courage, commitment and creativity to achieve excellence. We believe that we should always show compassion to others, making decisions without self-interest and supporting all those in our community to be happy and successful. We must have courage, never being afraid of failure but embracing it to learn from our mistakes and better ourselves. We are committed, not just to reaching academic success but to enriching ourselves as scholars, sportsmen and women, artists, musicians, actors, debaters and anything else we set our minds to.

Finally we are creative, always being willing to consider different solutions and think deeply about the challenges we face as individuals and as a society. Our admissions criteria are designed to support students from a wide range of different backgrounds gain access to the world class education that we provide.

Admission Number

The School admits 150 boys into Year 7 each year on the basis of their ability. Included in this number are all boys for whom Wallington County Grammar School (WCGS) is the named School on their Education, Health & Care Plan (EHCP) and who meet the School's Admission Criteria.

Boys will be regarded as being of selective ability if they reach the combined qualifying standard from the Selective Eligibility Test (SET) and the WCGS second stage test. In the event that the number of eligible applications exceeds the number of places available an oversubscription criteria will apply.

Application Process

The School will form part of the Pan London Co-ordinated Admissions Process and so those interested will have to complete a Common Application Form (CAF) which will ask for choices of schools in preference order.

If you are interested in a place at Wallington County Grammar School, you must list our School as a preference on your CAF.

In order to make a valid application, your son will need to reach the Wallington County Grammar School combined qualifying standard from the SET and the second stage test in order to be eligible to be considered for a place at our School. The SET will be held in the autumn term of 2022.

A joint second stage entrance test will be held a short while after the SET in the autumn term of 2022 and this is a test run jointly by Wallington County Grammar School, Sutton Grammar School and Wilson's School.

<u>All three schools will separately set their own qualifying standard after the joint second stage</u> test, so as a result, reaching the qualifying standard for one school does not guarantee reaching it for all three schools.

The closing date for completion of the CAF is 31st October 2022.

Offers of secondary school places will be made by the Local Authority on 1st March 2023 (or the closest working day if this day falls on a weekend), also known as National Offer Day.

Oversubscription Criteria

1. A Looked After Child (LAC) or Previously Looked After Child (PLAC), but immediately after being looked after became subject to adoption, a child arrangements order or special guardianship order.

A Looked After Child (LAC) is a child who is (a) in the care of a Local Authority, or (b) being provided with accommodation by a Local Authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989).

A Previously Looked After Child (PLAC) now includes children who appear to the Admissions Authority to have been in state care outside of England but ceased to be so as a result of being adopted. A child is regarded as having been in state care outside of England if they were in the care of, or were accommodated by, a public authority, a religious organisation, or any other provider of care whose sole main purpose is to benefit society.

2. Entrance Testing

In rank order of performance in the Selective Eligibility Test (SET) and the second stage entrance test. The total number of places awarded under criteria 1 and 2, together with those with the School named in an Education, Health & Care Plan (EHCP) will not initially exceed 110.

3. Pupil Premium (PP)

In rank order of performance in the SET & second stage entrance test. Up to 25 places for those boys who are successful in reaching the WCGS pass mark from the Selective Eligibility Test (SET) and second stage test and are eligible for Pupil Premium (PP) through their current school at the time of registering for the Selective Eligibility Test (SET). Any unfilled places in this criterion on National Offer Day and thereafter will be filled by criterion 2.

4. Sutton Post Codes

In rank order of performance in the SET and second stage test. Up to 15 places for those boys who are successful in reaching the WCGS pass mark from the Selective Eligibility Test (SET) and second stage test where the permanent Home Address is one of the postcodes SM1, SM2, SM3, SM4, SM5, SM6, SM7, KT4 8---, CR0 4 --, and CR4 4 --, at the time of Common Application Form (CAF) submission deadline. Any unfilled places in this criterion on National Offer Day and thereafter will be filled by criterion 2.

5. Children of permanent staff

Children of permanent staff at Wallington County Grammar School who have been recruited to fill a vacant post where there is a demonstrable skill shortage as determined by Folio Education Trust or those who have worked at the School for 2 consecutive years or more.

If you are a member of staff working at Wallington County Grammar School and you wish to make an application to this School for your son, please ensure the Admissions Officer is contacted and informed of your wish to be considered for a place in this admissions band. Please be aware of any conditions that may apply (such as the need to pass any entrance tests).

Please note:

The school will pass more boys from the SET and our second stage test than we have places for to take into account the number of students taking the test who may also be interested in other selective places at alternative grammar schools. Boys who reach the qualifying standard the SET and our second stage test for our school will be able to list our school as a preference on their Common Application Form (CAF) and can be considered for a place at Wallington County Grammar School.

<u>Reaching the qualifying standard in the Selective Eligibility Test (SET) and our second stage</u> <u>test does not mean a place at Wallington County Grammar School will be offered as we</u> <u>pass many more boys than we have places for.</u>

Tie-break

In the event two or more boys have the same rank order and where the admission would exceed the number of places available, places will be allocated in the order of the distance of their homes from the main pedestrian entrance of Wallington County Grammar School measured in a straight line distance between the centre of the property and the front entrance of the school as determined by the London Borough of Sutton's Geographical Information System.

If 2 students lived the same distance from the school, then a random allocation will be made by an independent person.

Admission of children outside their normal age group

Parents/carers may request that their child is admitted outside of their normal age group.

Parents/carers should provide supporting documentation at the time of registering for the Selective Eligibility Test (SET), specifying why admission out of normal year group is being requested.

For example, a summer born child who deferred the start of schooling will always have been out of date range with their year group and supporting documentation will be requested when the parent/carer registers online for the child to sit the Selective Eligibility Test. Or a child relocating to the UK from overseas may be placed in a different academic year group to that of other boys with the same age range.

Each request for admissions out of normal year group will be reviewed and if this request is not accepted by Wallington County Grammar School, the parent/carer will be informed and we aim for this to happen before the SET or our second stage test is held.

Waiting lists

If a boy is eligible to be considered for a place at our School but is not offered a place (as long as the school place being offered to you is a lower preference on your CAF than where you listed Wallington County Grammar School), your son's details will be placed on a waiting list until the end of December after his first term in Year 7 at Secondary school. This waiting list is ranked in accordance with our Admissions Criteria. If a place at our School becomes available in Year 7 between March 2023 and December 2023, the next eligible boy on the ranked waiting list will be offered the place without having to sit a further Entrance Examination.

On 31st December 2023, this ranked waiting list will be cancelled and any boys wishing to be considered for a future vacancy will be provided with information on how to make a mid-term application via the Local Authority.

Appeals

All applicants refused a place at our school have a right of appeal to an Independent Appeals Panel constituted and operated in accordance with the School Admission Appeals Code.

The right to appeal is to an Independent Appeal Panel set up in accordance with section 85(3) of the School Standards and Framework Act 1998. Appeals Documents can be requested in writing or can be downloaded from the school's website and the parent/carer appealing must set out the reasons on which the appeal is based. The completed Appeal Against Admission Form and any supporting documentation a parent/carer wishes to provide should be copied and 5 complete packs provided to the school.

(<u>Please note</u> that appeals can only be lodged from National Offer Day on 1st March 2023 when a parent/carer is informed by their Local Authority whether they have been unsuccessful in being offered a place at Wallington County Grammar school).

Notes

Entrance Testing:

The first stage entrance test is the Selective Eligibility Test (SET) which is run in conjunction with the five other selective and partially selective schools in the London Borough of Sutton. The SET consists of a multiple choice Maths and a multiple choice English paper.

If your son is successful in reaching the qualifying standard from the SET, he will then be invited to sit a second stage test. This second stage test is run jointly with Sutton Grammar School, Wilson's School and Wallington County Grammar school. This second stage test consists of a Maths paper and an English paper.

The outcome of both of these tests will be used by each of the three schools to determine eligibility for places at their school.

If due to exceptional circumstances the dates of the tests have to be amended, for example for a Covid-19 lockdown. In this instance the school will publish the revised dates of the entrance test/s on our website.

Pupil Premium (PP):

If your child is successful in the Selective Eligibility Test (SET) and our second stage test, parents/carers will be asked to provide proof/verification from your child's Primary School that your child was receiving Pupil Premium (PP) at the time of registering for the Selective Eligibility Test.

This evidence will only be requested after it has been confirmed that your son reached our school's qualifying standard from the combined SET and our second stage test. Doing so means that your son can then be considered for a place in this additional admissions band.

Home Address:

The home address is where a child normally lives. Where a child lives with parents with shared parental responsibility, each for part of a week, the address where the child lives is determined using a joint declaration from the parents stating the pattern of residence. If a child's residence is split equally between both parents, then parents will be asked to determine which residential address should be used for the

purpose of admission to school. If no joint declaration is received and the residence is split equally by the closing date for applications, the home address will be determined to be the address where the child is registered with the doctor. However, all evidence will be taken into account. If the residence is not split equally between both parents, then the address used will be the address where the child spends the majority of the school week. In some cases, where distance is a relevant factor in admission decisions, a different address may be used if a family unit owns or has access to another property.

All school admission applications for school places are subject to address checks to ensure school places are allocated fairly and in accordance with published admission arrangements.

These checks will be conducted by the home Local Authority; where a fraudulent address or an address of convenience are found to have been used, the application and any subsequent offer may be withdrawn.

Applicants living outside of England may only submit an application if they have a linked address within the Local Authority area, and documentary evidence must be supplied to show they will return to the address prior to the September in the year of entry; this address must not be an address of convenience.

If parents/carers wish to discuss their circumstances prior to making their application, they should contact their home Local Authority.
